The closest airport is about 65 km to the project area which is the Koca Seyit airport and it is open to international flights. The project area is about 135 km to İzmir Adnan Menderes Airport. There are high tech greenhouse companies such as Agrobay, YDA Agriculture, Vegevital, Kuzey Farm, Hazine Tarım, Mübay and Sedir.





- Geothermal energy resources will be used in the most efficient way with a fully automated central heating system, and geothermal production will be made in accordance with the technique in a fully closed circuit with production and reinjection wells.
- With the management of all geothermal resources in the region from a single center, the renewable feature of the geothermal resource will be preserved.






GEOTHERMAL ENERGY

- For the first time in Turkey, a geothermal resource exploration licence was obtained on behalf of a Specialized Organized Industrial Zone based on Agriculture.

Location of geothermal wells in and around our project area.






RENEWABLE ENERGY



It is aimed to use geothermal spring water in the heating of greenhouses in Dikili Agricultural Based Specialized Greenhouse Organized Industrial Zone. Also, it is aimed to benefit from wind energy systems (WES), solar energy systems (SES), and biogas energy together with geothermal energy. It is aimed to create a hybrid energy source in the project with WES, SES, and Biogas systems, which will be used in an integrated manner with geothermal energy.

WIND ENERGY

It is the area where Wind Power Plants will be established. There will be 2 Wind Turbines on 2 parcels of 58 decares.

BIOGAS ENERGY

It is the area where the Biomass Plant will be established. A biomass plant will be established on an area of 38 decares.

It is the area where the Solar Energy will be established. 1 parcel has been separated and has a size of 169 decares.




